

THE ARC OF FAITH

At 16, I walked out of the Catholic Church, wanting to rid myself forever of its superstitions and medievalisms. I did not know then that, with my first step on the other side of the threshold, I had laid my foot in a trap. I know now who placed it.

St. Joan of Arc, whose feast day is May 30, died in 1431, burned at the stake by the English, after conviction of heresy by pro-English French churchmen. The Church reversed the conviction in 1456, though obviously too late to reverse the execution of sentence. Most saints who have had military careers retire their weapons before they begin their new careers as saints. In Joan's case, the two careers coincided.

Her story can barely be believed: An illiterate peasant

claiming to be called by God, led by voices, seeking charge of the badly demoralized French armies in a campaign to eject the English from France.

The campaign was ultimately successful, though the success was achieved only after Joan's death.

She sounded at the beginning like a badly deluded child, but managed, by an extraordinary convergence of circumstances, by sheer force of personality, and, quite possibly, by the revelation of a secret to the future Charles VII

that only he knew, to persuade Charles to hand over to her the fate of her nation.

Her military career lasted about two years. She said she was sent by God, but her military successes persuaded the English that she was a witch. She was captured at Compiegne in May of 1430, and slowly ushered to trial for heresy in Rouen, France. The original trial transcripts are maintained to this day in the national archives of France. Read the transcripts for yourself (they are available in English online); you may be surprised to learn that some attempts have been made to defend the integrity of the canonical proceedings against her. It is a hopeless fantasy: Joan was doomed, the victim of a preordained conclusion that infected her cross-examination from beginning to end.

I first encountered the transcripts, apparently by chance, in



1991. Because of my profession as an attorney, the transcripts made a special appeal to my curiosity. Soon, however, the beauty and power of Joan's personality, evident on every page, overtook me. I was no longer curious; I was spellbound.

In fact, it occurred to me even then that I had not encountered that kind of beauty before, and was at a loss for the right words to describe it. Though I cannot count myself among the luminaries she has vanquished, the list includes some of the hardest-headed great personalities of the late modern era: Mark Twain, G.B. Shaw and Winston Churchill, for example. St. Therese of Lisieux adored Joan, calling her "my beloved sister." My own profound attraction to Joan, however, could not compensate for the disturbance of conscience that occurred when I learned she had a great love for the Mass, which I had never liked. As a child, as scandalous as it might sound, when I prayed at Mass it was as if I were praying for the Mass to be over. Joan's love for the Mass, and my dislike of it, became a barrier.

My friendship with Joan finally grew to a point, however, where I realized the impasse would have to be broken, and the barrier dismantled: I went to confession on May 29, 1992. The next day, Saturday, May 30, 1992, Joan's feast day, I went to Mass and received Communion for the first time in nearly 25 years. Since then, I have attended Mass 3-4 times a week. To miss Mass now is to suffer. The sudden reversal is as mystifying to me as it might be to you.

I left the Catholic Church looking for a better argument. I looked in the West, and in the East, and never found one. Faith, I discovered, probably later than most, was not the product of a deduction or a syllogism. Faith is not opposed to reason, but, in the end, it is no more a deduction than is a meeting with a loved one. Faith is encounter, communion. I had left the Church in search of an argument, and was retrieved by a person.

The beauty of the saints is not their own. Theirs is a reflected or refracted beauty, and we are, in the genius of the divine plan, drawn by indirection and even misdirection, precisely because there is so often something within that must be healed before we can look directly at the Son. •

He served as Diocesan Vocation Director from 1986-1993, and Chaplain of St. Francis High School in Mountain View, from 1987-1992. He was Pastor of St. Nicholas Church (Los Altos) from 1993-2005, and now serves



as Pastor of Sacred Heart Church in Saratoga, California.
